1. Name of the Society:

3. Aims and Objects:

The aims and objects for which the association is established are as under:

(a) To promote the improvement of Public health.

(b)To educate the public/people of Etawah in the matters of health and to promote public relation.

(c)To promote the study of medical science by means of cme, books and journals and discourses on patients and subjects.

(d) To educate the public on matters of sanitation, immunisation and Hygiene through local bodies.

(e)To co-operate and co-ordinate with the District Administration pertaining to establish a blood bank in IMA Branch Etawah building and to encourage the people of Etawah for Blood Donation.
